CHAPS payment out

We contacted you last year to advise that we were reducing the price of CHAPS payments to match Faster Payments as there is currently no ability to send a future dated Faster Payment in HSBCnet. This reduction allows you to send future dated CHAPS payments instead, without having to pay higher fees.
