#### Footnotes

- Bacs includes payments made through Bacs Schemes, such as Bacs Direct Credits - either via HSBC Innovation Banking or a bureau standing orders and Direct Debits.

Bacs Direct Credits require a noncommitted credit facility which will need to be approved and in place before payments can be made. Bacs bureaus may charge additional fees.

- Cash and cheque deposits can be made at any HSBC branch or Post Office counter in the UK (however, Post Office counters are unable to accept foreign currency cheques).
- When your account is overdrawn without a pre-authorised overdraft as described in our Banking Terms and Conditions of HSBC Innovation Banking.
- Guaranteed OUR is a surcharge added to any International Payment (SWIFT) made out of your account, where you have selected the charging option OUR. This will be charged separately and in addition to outgoing International Payments (SWIFT) fees.
